

# Terms and Conditions Governing ZKB Savings Accounts Plus (2013 edition)

# 1 Scope of application

These Terms and Conditions define the terms and procedures applying to ZKB Savings Accounts Plus at Zürcher Kantonalbank (hereinafter referred to as the "Bank").

### 2 Interest settlement

Any interest shall be credited to or debited from the account on an annual basis.

### 3 Bonus interest rate

If at the end of the year the year-end balance on the ZKB Savings Account Plus as determined by the Bank (excluding any interest earned) is higher than the year-end balance of the previous year (or of the first calendar year following opening of the account), the Bank may credit the account with additional interest by way of a bonus.

# 4 Statements of account

An account statement, including a statement of interest, shall be issued not less than once a year and sent to the correspondence address notified by the account holder. Amounts credited to the account, with the exception of account transfers and any salary or pension payments credited, shall be notified by means of announcements

# 5 Rates and charges

The Bank shall determine the following rates and charges:

- Interest rates, interest levels and maximum amounts on which interest is payable;
- Bonus interest rates and bonus interest levels;
- Account maintenance and transaction charges.

Rates and charges are determined by the separate price lists valid at any given time, which are also published on the internet and are available on request at any time. The Bank may amend the rates and charges at any time, specifically when the market situation changes or for other objective reasons. Any changes will be made in good faith and appropriately notified to the account holder. The account holder shall be notified in advance of any amendments to account maintenance and transaction charges.

### 6 Deposits

The Bank may temporarily limit its acceptance of deposits at any time for objective reasons.

### 7 Withdrawals

The account holder may withdraw a maximum of CHF 10,000 in deposits per calendar month at any time. The account holder shall give the Bank not less than six months' prior notice of any withdrawals exceeding this amount.

The Bank may pay out amounts exceeding the aforementioned withdrawal limit with immediate effect, subject to deduction of a withdrawal charge. No withdrawal charge shall be deducted from withdrawals relating to

- payments of interest and agreed repayments of principal owed to the Bank;
- investments in bonds issued by the Bank;
- transfers to other accounts held at the Bank with notice periods at least equivalent to that applying to the account;
- any negative interest rates introduced by the Bank.

# 8 Termination of business

Both the account holder and the Bank shall be entitled to terminate ZKB Savings Accounts Plus with immediate effect at any time, provided that the appropriate notice period is given in respect of credit balances exceeding the aforementioned withdrawal limit.

In the event of termination by the Bank, the Bank shall send notice of termination in writing to the correspondence address last notified to the Bank by the account holder. Interest shall cease to be payable once the notice period has elapsed.

### 9 Amendments to these Terms and Conditions

The Bank reserves the right to amend these Terms and Conditions at any time. Any such amendments will be communicated to the account holder in an appropriate manner and be deemed to have been accepted unless an objection is received within 30 days of notification.

## 10 Additional provisions

Additionally, the Bank's General Conditions shall apply.
