

# Structured addresses in the QR-bill

## Mandatory requirements for invoicing with QR-bills from 21 November 2025

Due to regulatory requirements, the Swiss financial center is implementing changes to the QR-bill. As of 21 November 2025, the new Implementation Guidelines QR-bill Version 2.3 will apply when creating QR-bills. From this date, only structured addresses (Address Type S in the Swiss QR Code) will be permitted in the Swiss QR Code of the QR-bill. Unstructured or combined addresses (Address Type K) will no longer be allowed.


After 21 November 2025, the seamless processing of QR-bills with unstructured or incomplete addresses in the Swiss QR Code will no longer be guaranteed. QR-bills with unstructured addresses in the Swiss QR Code may be rejected by the payer's financial institution or at the post office counter.

### Which address information in the QR-bill is affected?

- A Address of the invoice issuer** or payee  
In the payment section: **Account / Payable to**

- B Address of the payer** or debtor  
In the payment section: **Payable by**

### What do you need to do now?

1. Check whether your QR-bills already contain structured and complete addresses in the Swiss QR Code. Structured addresses must include at least the name, city, and country.
2. Complete your address master data, e.g., in your business/invoicing software, in a structured format with street, building number, postal code, city, and country.
3. Contact your software provider if your system does not generate QR-bills with structured addresses.
4. Ensure that, by 21 November 2025 at the latest, you provide your debtors with QR-bills containing only structured addresses and advise your customers to adjust any standing orders.

#### Note

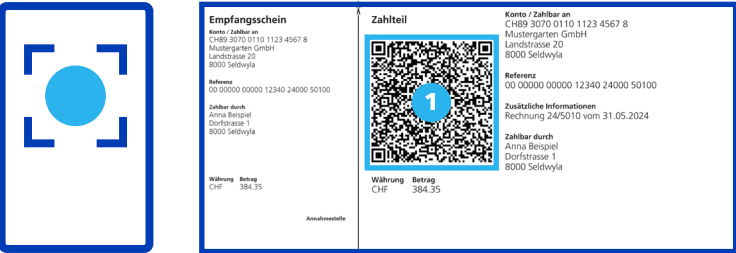
- If you ordered your QR-bills from Zürcher Kantonalbank, they already include structured and complete addresses.
- Order QR-bills quickly and easily via eBanking (search: QR Invoice), either electronically in PDF format or in paper form.

**How can I, as an invoice issuer, determine whether my QR-bills already contain structured and complete addresses in the Swiss QR Code?**

The visible part of the payment part does not indicate whether the address information is structured or unstructured. The address type is only visible in the Swiss QR Code.

- 1 Scan the Swiss QR Code with a QR scanner app on your smartphone.



- 2 Check the address type (**S** = structured or **K** = combined/unstructured) before the respective address, as well as the completeness of the address information. **At a minimum, the name, city, and country must be present.**

- A** Payable to: Invoice issuer / Payee, Data Group Cdtr (Creditor)
- B** Payable by: Ultimate debtor, Data Group UltmtDbtr (Ultimate Debtor)
